## 2023 GRANT APPLICATION

Feather River Food Co-op and Twin Pines Cooperative Foundation collaborate to award micro-grants to local non-profit and cooperative organizations. The Give Where You Live Campaign at our co-op can support these efforts and others in your community.

**A total of \$2,000 will be donated in 2023.**

***To apply:* You must also include the following documents with this application**

1. A narrative that includes:
  - a. A short description of the mission, goals, and activities of your organization (200 words or less)
  - b. Specific information regarding the purpose/project to which the Cooperative Community Fund grant would be allocated
  - c. A description of how the program or organization aligns with the Co-op's mission statement
2. A copy of your nonprofit or cooperative status, if applicable

***Granting Criteria***

- 1) Grants will be given to non-profit and/or cooperative organizations.
- 2) Grants will be given to organizations whose purpose and activities address these issues:
  - Agriculture • Food & Hunger • Environment • Community • Cooperatives
- 3) Preference will be given to organizations based and operating in the local area.
- 4) Preference will be given to organizations with annual budgets of less than \$50,000.

***Stipulations***

- 1) Funds may not be used for political or lobbying efforts.
- 2) **Organizations receiving grants are asked to submit a press release/letter/kudos to local media to help publicize the Cooperative Community Fund.**
- 3) Organizations receiving grants are asked to send a representative to accept the grant check in person at a coordinated place and time.

While every effort is made to accept most organizations and programs, we do not guarantee that every applicant will be chosen. You are welcome to keep applying for future years, and we also encourage you to apply for **Round Up @ the Register**.

**Paperwork must be completed in full – incomplete applications will delay processing and funds awarded**

Fund recipients are required to complete all paperwork in full before being considered. All application materials are available in-store or online under "Cooperative Community Fund" tab on the home screen.
